Form 990, Part III, Line 4a:

The Transitional Housing Program assists clients in finding safe, affordable housing. Continued supportive services are also a part of this program. These services can last for up to two years. Many of our clients who find shelter in the Safe House, transition into apartments of their own. During the fiscal year we assisted 77 individuals with finding either temporary or permanent, affordable housing. There were 1,037 services provided to clients to help them with household establishment.

Form 990, Part III, Line 4b:

Our emergency shelter is a safe, confidential house located in a residential neighborhood. It is a real home with a beautiful kitchen, private bedrooms and bathrooms, indoor and outdoor play areas for children, and a cozy family room where clients can relax or hold family meetings. Our staff is there around the clock to work with clients on individualized plans to find resources for a future free of violence. We also staff a 24-hour crisis line. During the fiscal year, 48 adults and 50 children were provided safe, confidential shelter and supportive services at the emergency shelter for a total of 3,568 shelter days. 2,382 crisis line calls were received at the shelter by our domestic violence counselors. 61 adults and 26 children attended peer support counseling sessions held both at our shelter and at other locations.

Form 990, Part III, Line 4c:

Crisis Intervention: The Safe Solutions program is designed to work specifically with adults who have co-occurring domestic violence, drug or alcohol dependency issues and/or mental health issues. The program was designed using trauma informed practices and uses intensive case management to help adults discover triggers and coping skills to guide them to safety and support. There is a strong emphasis on working toward successful connections to resources that support their recovery and healing. During the fiscal year, we served a total of 243 clients, which included providing transportation for 16 clients for social services, health and court appointments. The Court Advocacy Program provides help with the process of filing for protective orders and providing advocacy to victims of domestic violence. NEWS Court Advocates work together with clients to find resources pertaining to child custody, visitation, and civil issues related to abuse. NEWS Court Advocates are co-located at the Monarch Justice Center. During the fiscal year, there were 58 restraining orders filed on behalf of clients and 216 court appearances on behalf of clients.

Form 990, Part III, Line 4d	OTHER PROGRAM SERVICES 4: The NEWS Volunteer Program provides two 60-hour training sessions per year, free of cost, for those interested in becoming Domestic Violence and Sexual Assault Counselors. Volunteer opportunities include becoming a member of the Domestic Violence Response Team. The Domestic Violence Response Team Program utilizes a team of trained domestic violence and sexual assault counselor volunteers to respond immediately to victims of domestic violence or sexual assault at the request of law enforcement. They go either directly to the scene of an incident or to a designated safe location. The counselors provide emotional support, information, safety planning, and resources. They work with each client to develop a plan for follow-up services. Volunteers may also help in providing court advocacy services and working at the safe house on the 24-hour crisis line. We trained 12 volunteer Domestic Violence Counselors during our fiscal year. Volunteers provided our organization with an average of 282 hours of service per month. OTHER PROGRAM SERVICES 5: The Sexual Assault Victim Services (SAVS) Program is the Rape Crisis Center serving survivors of sexual abuse throughout Napa County. This program provides 24 hour immediate response by trained Rape Crisis Counselors for both adult and child survivors of sexual abuse and their family members. SAVS offers support and advocacy through the criminal justice process, assistance with filing for Victim of Crime Compensation, counseling and support groups. During the fiscal year, we rendered assistance to 262 clients and filed 32 Crime Compensation forms on behalf of clients. OTHER PROGRAM SERVICES 6: The Kids Exposed to Domestic Violence Program (KEDS) provides several components to assist children who have been exposed to violence at home. Children are assessed and are offered resources to build protective factors and reduce risk factors for future adverse affects as a result of exposure to violence. Follow up and support is offered to non-offending parents to assist in their children's individualized case plan. Parents receive education and information on how they can build protective factors for their children. The children may participate in NEWS' Kids Club weekly support groups where a curriculum is offered to help build safety and self esteem while doing fun and creative activities. During the fiscal year, 26 children participated in weekly support groups, while 109 adults and 131 children received other services under this program. OTHER PROGRAM SERVICES 7: Crisis Intervention: The Safe Solutions program is designed to work specifically with adults who have co-occurring domestic violence, drug or alcohol dependency issues and/or mental health issues. The program was designed using trauma informed practices and uses intensive case management to help adults discover triggers and coping skills to guide them to safety and support. There is a strong emphasis on working toward successful connecti

During the fiscal year, we serve d a total of 243 clients, which included providing transportation for 16 clients for socia l services, health and court appointments.The Court Advocacy Program provides help with th e process of filing for protective orders and providing advocacy to victims of domestic vi olence. NEWS Court Advocates work together with clients to find resources pertaining to ch ild custody, visitation, and civil issues related to abuse. NEWS Court Advocates are co-lo cated at the Monarch Justice Center. During the fiscal year, there were 58 restraining ord ers filed on behalf of clients and 216 court appearances on behalf of clients. OTHER PROGR AM SERVICES 8: Monarch Family Justice Center:NEWS continued its collaboration with local a gencies as part of Napa County's family justice center model, the Monarch Justice Center (MJC). Core partners include the Napa County District Attorneys Office and the Victim Servi ces Division and the City of Napa Police Department. NEWS and MJC partners continue to sel f-fund a small number of service staff who are co-located in the building. Co-location of service staff facilitates coordination across agencies and streamlines service delivery to clients in need. NEWS and its partners are committed to pursuing sustainable funding to s upport the operations of the MJC in order to expand the number of partner organizations an d potential locations available to community members to receive services.
